This is the second AMENDMENT to AGREEMENT PTD0465 entered into between the Washington State Department of Transportation (hereinafter referred to as "WSDOT"), and City of Everett (hereinafter referred to as "CONTRACTOR"), and/or individually referred to as the "PARTY" and collectively referred to as the "PARTIES,"

### RECITAL

WHEREAS, the State of Washington in its Senate Bill 1125 Sessions Laws of 2023, Section 221 authorizes funding for Public Transportation Programs and other special proviso funding as identified in the Move Ahead Washington budget through its 2023-2025 biennial appropriations to WSDOT; and

WHEREAS, the PARTIES amend AGREEMENT PTD0465 to:

- Align the biennial aging of the contract with the most recent enacted budget bill by moving projected funds to current funds;

NOW THEREFORE, the following AMENDMENTS are hereby incorporated into AGREEMENT PTD0465:

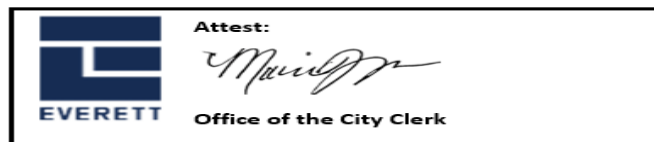
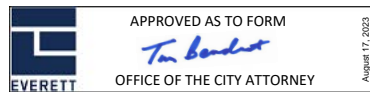
