

**AGREEMENT BETWEEN**  
**LIFE SCAN WELLNESS CENTERS**  
**AND**  
**LAW ENFORCEMENT OFFICERS AND FIREFIGHTERS**  
**HEALTH & WELFARE TRUST**  
**PARTICIPATING EMPLOYER**

**THIS AGREEMENT** is made between City of Everett, a Washington municipal corporation, a contributing employer to the LEOFF Trust (hereinafter the "Employer"), and Life Scan Wellness Centers (hereinafter "Life Scan").

**WHEREAS**, the Law Enforcement Officers and Firefighters Health and Welfare Trust ("LEOFF Trust") and Life Scan have entered into a Professional Services Agreement dated on or about October 4, 2021, as amended (hereinafter "PSA") to provide annual NFPA 1582/1583 physicals for eligible LEOFF participants;

**WHEREAS**, the PSA provides that the LEOFF will compensate Life Scan for each NFPA 1582/1583 physical performed;

**WHEREAS**, the PSA provides that Life Scan and the Employer will mutually agree to a time and place to perform the NFPA 1582/1583 physicals;



**NOW THEREFORE**, in furtherance of the above, the Parties agree to the following:


1. Life Scan will perform 45 NFPA 1582/1583 physicals at 2801 Oakes Ave, Everett, WA 98201, between October 30 and November 3, 2023. Employer agrees to communicate the availability of the NFPA 1582/1583 physicals to its employees and to identify to Life Scan all employees that will be receiving an NFPA 1582/1583 physical. Except for Section 2 below, LifeScan's work under this Agreement is at no cost to Employer.

2. Employer agrees that it will be financially responsible for the cost of the NFPA1582 physical if: (1) a LEOFF participant employed by the Employer fails to appear for his or her NFPA 1582/1583 physical and (2) after being provided an opportunity to reschedule, is either non-responsive to the request to reschedule or fails to appear at the rescheduled time slot. This Section 2 does not apply to persons not currently on the Employer's payroll (for example, this Section 2 does not apply to LEOFF retirees). The Employer is not responsible for any costs related to such non-payroll persons. LifeScan is responsible for collecting costs, if any, directly from non-payroll persons.

3. Sections VI, VIII, IX, X, XI, XII, XIII, and XV of the PSA are incorporated into this Agreement as if fully set forth herein, with "Employer" substituted for "LEOFF" and "Snohomish" substituted for "Spokane" for those Sections incorporated into this Agreement.

This Agreement may be in counterparts and may be signed in ink, electronically, or by transmission of pdfs.
