

AMENDMENT NO. 2 TO COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM NON-PUBLIC SERVICE SUBRECIPIENT AGREEMENT BETWEEN THE CITY OF EVERETT AND CHILDSTRIVE

This Amendment No. 2 is dated for reference purposes December 31, 2023. It is by and between the City of Everett, a municipal corporation under the laws of the State of Washington ("*City*"), and Little Red School House DBA ChildStrive ("*Subrecipient*").

RECITALS

- A. The City and Subrecipient are parties to the Subrecipient Agreement dated on or about January 11, 2023, for the funding of the "Roof Replacement at the Village on Casino Road Project," as amended by Amendment No. 1 (the "*Agreement*").
- B. The City and the Subrecipient desire to amend the Agreement for the purpose of extending the Time of Performance and grant project closeout to March 31, 2024.
