

**AMENDMENT NO. 2 TO  
RIGHT-OF-ENTRY AGREEMENT  
for The Boeing Company**

This Amendment No. 2 to Right-of-Entry Agreement (this "Amendment") is entered into as of December 11, 2023, between The City of Everett, ("City") and The Boeing Company ("Boeing") and amends the Right of Entry Agreement dated August 28, 2013 as amended by Amendment No. 1 dated May 16, 2018, (the "Agreement") related to the City owned property commonly identified as Snohomish County Tax Parcel Number **29043400404100**, between the same parties.

In consideration of the mutual promises of the parties set forth in this Amendment, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

**1. Term**

City and Boeing agree to extend the term of the Agreement by two (2) years, so that the term of the Agreement will expire on December 31, 2025.



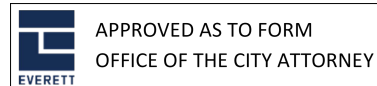
