The **Term** section of the Agreement is hereby extended by incorporating the following additional paragraph below:



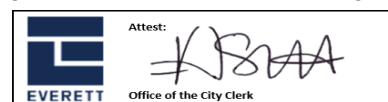
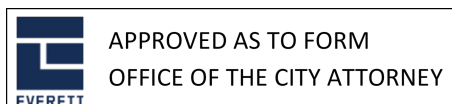
