Council Member Rhyne led the Pledge of Allegiance.

Council Member Bader recited the land acknowledgement.

The minutes of the June 12, 2024, meeting were approved.

MAYOR

Mayor Franklin stated the Mayor's Drug Crisis Task Force held their last meeting last week. She also stated the City is holding three information sessions regarding Proposition 1. She wished everyone a happy Fourth of July holiday. Mayor Franklin state the first downtown public restroom will open on July 1.

Police Chief John DeRousse introduced two new police officers.
