July 17, 2024

The regular meeting of the Everett City Council was called to order at 6:30 p.m., July 17, 2024, by President Schwab.

Upon roll call, it was found that Mayor Franklin and Council Members Rhyne, Bader, Tuohy, Vogeli, Zarlingo and President Schwab were present. Council Member Fosse was excused.

Council Member Bader led the Pledge of Allegiance.

Council Member Tuohy recited the land acknowledgement.

The minutes of the July 10, 2024, meeting were approved.

MAYOR

Mayor Franklin invited Police Chief John DeRousse to introduce a new police officer.

OATH - POLICE OFFICER

Moved by Council Member Tuohy, seconded by Council Member Zarlingo, to concur with the appointment of Brett Gailey as a new police officer.

Roll was called with all council members voting yes, except Council Member Fosse who was excused.

The City Clerk administered the oath of office, Mayor Franklin pinned the officer with their badge, and Council members congratulated Officer Gailey.

Mayor Franklin provided information on upcoming events: GeekFest, Rock The Boat, and Everett Fire Ultimate Sprinkler Day.

Mayor Franklin also stated Proposition1 information sessions will be held on July 27th at the Evergreen Branch Library at 11:30am, and July 30th at Everett Station at 5:30pm. Residents should be receiving their August 6th primary ballots and voter's pamphlets in a few days.

Council Member Rhyne commented on her attendance at Salty Sea Days, and the Lowell Neighborhood Association meeting. She also requested information about composting and recycling options at special events with the styrofoam ban approaching. She also stated Saturday the Port Gardner Neighborhood is having their community yard sale event, and Everett Station District Alliance is hosting their clean-up event at the Transit Station.

Council Member Bader commented on his attendance at the Library Board meeting.

Council Member Touhy provided an update from the Sno911 Board of Directors monthly meeting.

Council Member Vogeli congratulated new Everett Police Officer Brett Gailey, and spoke on housing sales and costs.

Council Member Zarlingo commented on his attendance at the Parks and Quality of Life Committee meeting and Snohomish County Law and Justice Counsel meeting.
