

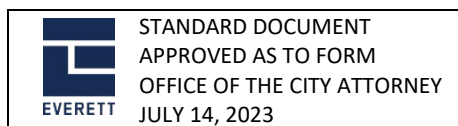

RE: Inventory of Additional Trees for The City Of Everett

Dear Kimberly,

We appreciate the opportunity to continue our inventory of public trees managed by the City of Everett, Parks and Facilities. You have requested additional effort under our professional services agreement (dated 12/08/2022). With your approval, this letter can form an amendment to the agreement and function as a fee schedule for additional tree inventory services within RFP #2022-061.

Through discussions with you and your team, we identified **696 hours of additional tree inventory effort** at various public properties throughout the City of Everett (Table 1). Davey Resource Group (DRG) will provide arborist technicians to inventory trees in alignment with the scope of work and at locations as directed by City staff representatives. Your staff would be able to prioritize our work locations and engage our team according to your schedule.

DRG will provide inventory arborists at an hourly rate of \$135.00 and invoice according to portal-to-portal marshaling from offices in Seattle, WA. An additional 80 hours will also be budgeted as a contingency for any requested quality control efforts or consultations with Everett staff by an ISA Certified Arborist with Tree Risk Assessment Qualifications at \$160.00 per hour. Any effort requested in 2025 will be subject to an annual rate escalation of 6%.

The above services and rates would be invoiced monthly according to a not-to-exceed budget of \$106,760.00 and honored through 12/31/2024.
