

As allowed by Section 2.4 Changes in Scope of Work of the RFP:

1. Added: the finished booklet size of 80 inside pages plus a 6-page cover. Pricing for the following print quantities shall be as follows:
  - a. 15,000 booklets for \$9,709.87.
  - b. 20,000 booklets for \$11,434.81.
2. Base year pricing shall remain unchanged, as shown in the original proposal submitted.
