

AMENDMENT NO.¹ EVERETT FORWARD ROUND 2 BENEFICIARY AGREEMENT

This Amendment to Beneficiary Agreement ("Amendment") is effective as of the date of the Mayor's signature below, and is between the City of Everett, a Washington municipal corporation (the "City"), and the Beneficiary identified below ("Beneficiary"). The City and Beneficiary are parties to the Everett Forward Grant Round 2 Beneficiary Agreement described below, as may be previously amended ("Agreement"). In consideration of the covenants, terms and conditions set forth below, and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Beneficiary agree to amend the Agreement as set forth below:

Amendment	The Agreement is modified to extend the Agreement period so that it is from 12/31/2024-12/31/2025 The first sentence of Agreement Section 12 is amended to state: "If Grantee has unspent grant proceeds on hand as of 12/31/2025 , Grantee shall return all unspent grant proceeds to the City within ten (10) calendar days." These amendments are effective regardless of the date(s) this Amendment is signed by the parties.
Standard Amendment Provisions	This Amendment will be signed with AdobeSign, which is fully binding.
	All provisions in the Agreement shall remain in effect except as expressly modified by this Amendment.
