



AMENDMENT

This amendment (“**Amendment**”) supersedes and amends the previously executed agreement between the Parties, dated 10/1/2024, relating to the provision of services by Flock Group Inc. (“**Flock**”) to WA - Everett PD (“**Customer**”) and any schedules or exhibits attached thereto or incorporated therein by reference (the “**Agreement**”). 
Special Terms:


Standard Implementations. Flock is crediting \$450 credit to Everett PD so now they will be charged \$1,500.
