



**AMENDMENT NO. 3

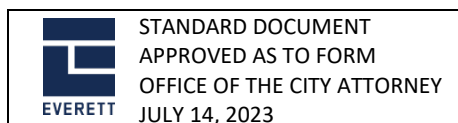
