

## **AMENDMENT 2 TO THE INTERLOCAL SERVICES AGREEMENT BETWEEN CITY OF EVERETT AND SNOHOMISH COUNTY**

This Amendment 2 to the Interlocal Agreement between City of Everett and Snohomish County (“Amendment 2”) is entered into on the \_\_\_\_\_ day of \_\_\_\_\_, 2025 by and between Snohomish County, a political subdivision of the State of Washington (the “County”), and City of Everett, a public agency in Washington State (“Everett”).

### **RECITALS**

Whereas, the County and City of Everett (“Everett”) entered into that certain agreement executed on December 11, 2020, entitled “Interlocal Agreement”, amended by Amendment 1 dated September 27, 2024, hereinafter (the “Agreement”); and

Whereas, Astound provides a critical segment of the direct path for Verizon Wireless services from the County’s main campus site to the Westin Building in Seattle that is no longer needed by the County but may still be needed by other cities within the County; and

Whereas, Everett has requested continued access to this path as they still need this Verizon Wireless service for their first responders; and

Whereas, the increase to the Agreement to continue the service for Everett is Six Thousand Four Hundred Twenty-Six Dollars (\$6,426.00) as shown in Amended Appendix A of Exhibit A Supplemental Work Order SWO-20-01; and

Whereas, the “not to exceed” amount of the Agreement over the five (5) year contract term was stated at One Hundred Thousand Dollars (\$100,000.00) through December 10, 2025; and

Whereas, the “not to exceed” amount of the Agreement over the five (5) year contract term is increased to One Hundred Ten Thousand Dollars (\$110,000.00).

### **AGREEMENT**

NOW, THEREFORE, in consideration of the covenants hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the County and Everett agree as follows:

1. Section 2 Contract Maximum, is hereby amended to read as follows:
  2. Contract Maximum. All Supplemental Work Orders executed under this ILA shall not exceed an aggregate total of \$110,000.00.
2. Appendix A of Exhibit A, SWO 20-01, is hereby amended as attached and by this reference incorporated herein.

3. Except as expressly provided in this Amendment No. 2, all of the terms and conditions of the Agreement remain in full force and effect.

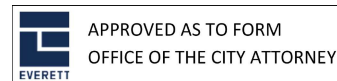
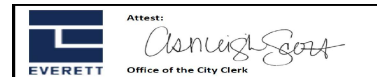

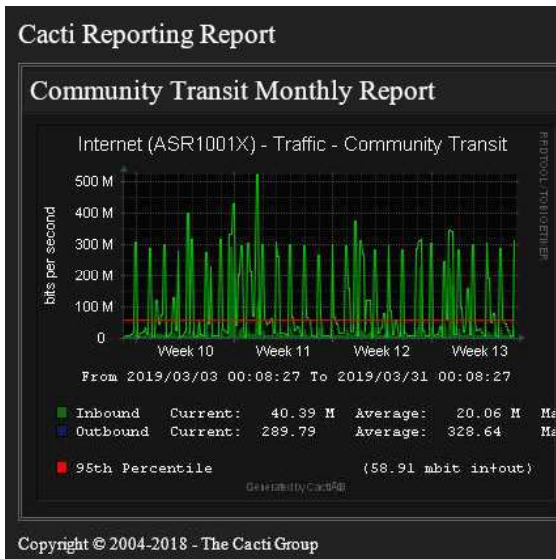

Internet usage to be reviewed quarterly and Everett will be billed on the 95<sup>th</sup> percentile.

SCDOIT uses RRDtool to graphically represent the customer's bandwidth and billing operations data on a monthly recurring basis.

Bandwidth data is measured from the customer's activated network interface port on SCDOIT internet colocation, gateway switch, and recorded in a log file every 1 minute. At the end of each month, the samples are sorted from highest to lowest, and the top 5% of bandwidth utilization data is discarded. The next highest measurement (95<sup>th</sup> percent) becomes the billable utilization for the month.
