#### Authorization for Electronic Funds Transfer from Greater Good Charities

This authority will remain in effect and all deposits will be directed to the financial institution indicated below until GGC receives either (1) a written notification terminating your authorization for direct deposits or (2) an updated Authorization for Electronic Funds Transfer form reflecting the changes to your financial institution information. Both written notifications must be submitted to GGC within a reasonable time to allow GGC to reflect those changes in your account.

This form must be returned with a completed IRS W9 form and a void check or bank letter clearly showing both the bank routing and account number.

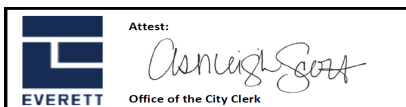
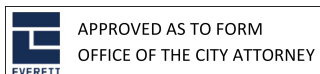
