Dogs Playing for Life Seminar Agreement



This Agreement is made and entered into as of <u>date of signature below</u> between and among Dogs Playing for Life (DPFL) and City of Everett (Host Shelter).

Terms of Agreement

The Host Shelter's Dogs Playing for Life[™] Seminar is scheduled to take place at the Everett Animal Shelter, 333 Smith Island Road, Everett, WA 98201 for a total of (3) three days.

The Host Shelter shall comply with the following:

Host Shelter commit to the dates and times provided by Dogs Playing for Life and will not cancel or reschedule without proper and timely notification. Specifically, if Host Shelter cancels within four (4) weeks (i.e., 28 days) of the scheduled and confirmed dates, the Host Shelter will be responsible for all costs incurred by DPFL with regard to cancelling staff and travel plans.

- No decisions regarding a dog's suitability for play group participation are made based on the dog's suspected breed or breed mix (all Recipient Host Shelter dogs are treated individually).
- The Host Shelter must participate in the DPFL's follow-up survey.
- The Host Shelter will provide all data requested by DPFL prior to the seminar, and at intermittent follow up periods as designated by DPFL. In exchange, the shelter may be invited to apply for a grant through the Lazin Animal Foundation, which sponsors data collection and follow up.


To the extent of Host Shelter's negligence, the Host Shelter agrees to hold Dogs Playing for Life[™], their officers, employees, successors and assigns, harmless from any cost or expense, including reasonable attorney fees, that may result from any claims, suits, actions and proceedings filed or brought in connection with or as a result of Host Shelter's activities.

Should the Host Shelter fail or neglect, in the reasonable judgment of Dogs Playing for Life, to meet some or all of the provisions above, Dogs Playing for Life shall have the right to terminate agreement upon timely written notice to the Host Shelter setting forth the purported breaches of the Host Shelter. Dogs Playing For Life shall give Host Shelter Sponsor the opportunity to cure such breach for a period of five(5) business days after delivery of the notice of breach.
