

July 9, 2025

The regular meeting of the Everett City Council was called to order at 6:31 p.m., July 9, 2025, by President Schwab.

Upon roll call, it was found that Mayor Franklin and Council Members Zarlingo, Fosse, Vogeli, Tuohy, and President Schwab were present. Council Members Bader was expected to be late and Council Member Rhyne was excused.

Council Member Zarlingo led the Pledge of Allegiance.

Council Member Tuohy recited the land acknowledgement.

Council Member Bader arrived at 6:32 p.m.

The minutes of the July 3, 2025, meeting were approved.

#### MAYOR

Mayor Franklin congratulated Deputy Chief Goetz on his promotion, advised that 24 high school youth interns are currently working throughout the city, and provided an update on various city events happening over the weekend.

#### PUBLIC COMMENT

The Council received no written comments and no members of the public spoke.

#### COUNCIL

Several council members congratulated Deputy Chief Goetz on his promotion.

Council Member Zarlingo thanked the young man and community for saving the life of a child at Silver Lake and thanked news organizations for publishing the safety initiatives provided by the Fire Department. He also attended the Snohomish County Tomorrow's Exploratory Committee.

Council Member Fosse encouraged the public to reach out to elected officials to ask clarifying questions during uncertain political times.
