The regular meeting of the Everett City Council was called to order at 6:30 p.m., September 3, 2025, by Vice President Zarlingo.

Upon roll call, it was found that Mayor Franklin and Council Members Bader, Rhyne, Vogeli, Fosse, Tuohy, and Vice President Zarlingo were present. President Schwab was excused.

Council Member Bader led the Pledge of Allegiance.

Council Member Fosse recited the land acknowledgement.

The minutes of the August 27, 2025, meeting were approved.

CITY ATTORNEY

City Attorney David Hall provided updates on the election cases in Superior Court and requested a 5-minute executive session, pursuant to RCW 42.30.110 (1)(i) regarding opioid settlements with Council action to follow. He also provided kudos to the City of Everett elected officials, past and present, for championing the lawsuits against pharmaceutical companies for the opioid crisis.

**Moved by Council Member Tuohy, seconded by Council Member Rhyne, to authorize the Mayor to execute a participation agreement with secondary manufacturers Alvogen, Amneal, Apotex, Hikma, Indivio, Mylan, Sun and Zydus, totaling \$125,000 with scheduled payments.**

**Motion carried.**


