

ADDENDUM #1

**INTERLOCAL COOPERATIVE AGREEMENT BETWEEN THE CITY OF EVERETT
AND MUKILTEO SCHOOL DISTRICT CONCERNING THE
SCHOOL RESOURCE OFFICER PROGRAM**

THIS ADDENDUM is between the City of Everett (the "City") and Mukilteo School District (the "District"). This Addendum is dated for reference purposes August 25, 2025.

RECITALS

- A. The City and the District are parties to the Interlocal Cooperative Agreement between the City of Everett and Mukilteo School District Concerning the School Resource Officer Program dated on or about September 1, 2024 (the "Agreement").
- B. Under Section 2 of the ILA, the District may extend the ILA:

The term of this Agreement may be extended for up to two (2) additional one (1) year terms (through August 31, 2027) by written notice from the District to the City. Prior to providing written notice of an extension, in compliance with RCW 28A.320 as applicable to SROs, the District must review and adopt the extension of the agreement, as described in Section 1.G. The District acknowledges that SRO services being offered by City are contingent upon sufficient legislative appropriation during current and subsequent fiscal years.

- C. The District has completed any necessary review and adoption of an extension of the Agreement. The District has determined to extend the Agreement for the 2025-2026 school year. The purpose of this Addendum is to formalize that extension. This Addendum does not amend the Agreement.
- D. The Mukilteo School District will reimburse the City of Everett Police Department for one annual training conference per year for each school resource officer that is assigned to the district. The reimbursement will cover the registration fee, travel, lodging, and any associated government per diem. The approximate cost for the annual training conference is \$3,100 per school resource officer.

NOW, THEREFORE, IT IS MUTUALLY AGREED THAT the Agreement is extended for the 2025-2026 school year.

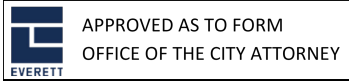
