The regular meeting of the Everett City Council was called to order at 6:30 p.m., October 8, 2025, by President Schwab.

Upon roll call, it was found that Mayor Franklin and Council Members Fosse, Rhyne, Schwab, Vogeli, Zarlingo, Bader, and Tuohy were present.

Council Member Bader led the Pledge of Allegiance.

Council Member Tuohy recited the land acknowledgement.

The minutes of the October 1, 2025, meeting were approved.

#### MAYOR

Mayor Franklin declared October 14, 2025, as "Leadership Day" by proclamation. Kathy Solberg, Leadership Snohomish County, accepted the proclamation and made comments.

Mayor Franklin also stated she would be declaring Everett Transit Route 12 as a free bus route for six months to address accessibility to stores brought on by the closure of Fred Meyer.

#### PUBLIC COMMENT

Council received five written comments and the following members of the public spoke: Kerry Reid, Annie Lyman, Holly James, William Parent, Andrea Tucker, and Lawrence Balogh.

#### COUNCIL

Several council members thanked Mayor Franklin for declaring Route 12 free to address the Fred Meyer closure and thanked the public commenters.

Council Member Rhyne commented on the Parks and Built Committee meeting held earlier this evening. She stated the Port Gardner Neighborhood meeting will be held Monday, and stated the Pinehurst-Beverly Park Neighborhood meeting would be hosting Community Transit on Tuesday October 21 for a route meeting. She also reminded citizens that Boards and Commissions applications are still open until October 20.

Council Member Tuohy stated the Monte Cristo Awards will be held Thursday, October 16 at APEX Everett. She also requested an update regarding Snohomish County's potential purchase of

a hotel to turn into housing. Mayor Franklin stated Snohomish County is working with the Everett Gospel Mission to expand shelter capacity instead of purchasing a hotel. Mayor Franklin also stated she would invite Snohomish County and the Everett Gospel Mission to Council to provide an update.

Vice President Zarlingo, as mentioned by a public commenter, reiterated that the Council of Neighborhoods is hosting a candidate forum at the Weyerhaeuser Room on Thursday, October 9.
