The regular meeting of the Everett City Council was called to order at 12:31 p.m., October 29, 2025, by President Schwab.

Upon roll call, it was found that Mayor Franklin and Council Members Bader, Rhyne, Vogeli, Tuohy, Zarlingo, and President Schwab were present. Council Member Fosse was excused.

Council Member Tuohy led the Pledge of Allegiance.

Council Member Rhyne recited the land acknowledgement.

The minutes of the October 22, 2025, meeting were approved.

MAYOR

Mayor Franklin read a proclamation recognizing October 28,2025, as National First Responder Day, and invited staff from the CARE Team, Public Works, and Police to accept the proclamation.
