

### **ATTACHMENT A: Scope of Services**

#### The Needed Work

Based on a review of materials and conversations with City of Everett personnel the CONSULTANT anticipates the following work to be formed under this agreement:

- 1. Initiate a process to assess the City of Everett budgets and financial condition.
- 2. Review the records and documents in the possession of the CITY, interview staff, review past reports and assess the status of the CITY's financial condition.
- 3. Identify and clearly portray the financial position of the City of Everett for the City Council.
- At the discretion of the City Council President, assess the budget process and make recommendations for alternative approaches that might better serve the City's needs.
- 5. Provide a written report describing the observations and recommendations related to the City's budget, financial condition and financial planning practices.
- 6. Debrief with the City Council and / or city staff as desired and directed by the Everett City Council President.
- 7. Provide in-depth review and observations for selected budget items at the discretion of the City Council President.
