



ORDINANCE NO. 4143-25

An ORDINANCE closing a special improvement project entitled “California Street Pedestrian & Bicycle Corridor” Fund 303, Program 119, as established by Ordinance No. 3738-20.

WHEREAS,

- A.** The special improvement project entitled “California Street Pedestrian & Bicycle Corridor” Fund 303, Program 119, was established to provide for identified improvements.
- B.** The project has been deferred to a future date and there are neither outstanding obligations to be paid nor uncollected revenues to be received.

NOW, THEREFORE, THE CITY OF EVERETT DOES ORDAIN:

Section 1. The special improvement project entitled “California Street Pedestrian & Bicycle Corridor” Fund 303, Program 119, as established by Ordinance No. 3738-20 be closed.

Section 6. The enactment of this Ordinance shall not affect any case, proceeding, appeal or other matter currently pending in any court or in any way modify any right or liability, civil or criminal, which may be in existence on the effective date of this Ordinance.

Section 7. It is expressly the purpose of this Ordinance to provide for and promote the health, safety and welfare of the general public and not to create or otherwise establish or designate any particular class or group of persons who will or should be especially protected or benefited by the terms of this Ordinance. It is the specific intent of this Ordinance that no provision or any term used in this Ordinance is intended to impose any duty whatsoever upon the City or any of its officers or employees. Nothing contained in this Ordinance is intended nor shall be construed to create or form the basis of any liability on the part of the City, or its officers, employees or agents, for any injury or damage resulting from any action or inaction on the part of the City related in any manner to the enforcement of this Ordinance by its officers, employees or agents.
