

## **TASER® PURCHASE, DISCLOSURE, AND WAIVER AGREEMENT**

This TASER® Purchase, Disclosure, and Waiver agreement (the “Agreement”) is dated as of 12/12/2025 and is by and between the CITY OF EVERETT (the “City”) and ACCREDITED SECURITY, a Nevada corporation (“Purchaser”).

The City has determined that this TASER® equipment is no longer suitable for City police use. The serial numbers (or other identifying information) for the TASER® units are attached (the TASER® units on the attached list, the “Tasers”). In accordance with the City's practices regarding surplus equipment, the City has determined to sell the Tasers to Purchaser.

### **AGREEMENTS**

City and Purchaser agree as follows:

#### **1. Purchaser Price**

The City will sell the TASER® equipment, and the Purchaser will purchase the TASER® units listed in Exhibit A. The purchase price is \$100 (ONE HUNDRED DOLLARS) for each fully functional working TASER® X2 shipped in a marketable Right Hand duty holster with cartridges. The purchase price is \$25.00 (TWENTY FIVE DOLLARS) for each fully functional working TASER® X2 without a right hand holster and without cartridges.

The purchase price is \$1 for each additional cartridge (X2) with expiration date of 2028 or later. If operational or repairable, the City will be paid for the item. Defective equipment sent to the purchaser will not be returned to the City. Therefore, if the item is not repairable to full operating condition, it will be disposed of, and the City will be issued a Certificate of Disposal.

Purchaser will pay the purchase price for all Tasers in full by cash or check or by credit payable toward the City's future purchases facilitated through Accredited Security. The Purchaser will deliver such payment to the City within 15 weeks after the Purchaser takes possession of the Tasers.

#### **2. Strictly AS-IS.**

Purchaser agrees that the tasers are sold strictly **"as-is"** and **"with all faults."** purchaser understands that any or all of the tasers could be dangerous, unsafe, and not in working order. The purchaser must inspect each taser prior to use to determine whether the taser is in working order and safe.

#### **3. No Warranty.**

The city makes **no warranty of any kind**, whether express, implied, statutory, or otherwise, including without limitation warranties of merchantability or fitness for a particular purpose.

**4. Sole risk.**

Any resale or use of the tasers by purchaser is at the **sole risk** of purchaser.

**5. Indemnity.**

Purchaser hereby agrees to defend, indemnify and hold the City harmless from any and all claims, liabilities, and losses arising from or relating to the resale or use of any of the Tasers after Purchaser takes possession of the Tasers.

**6. Waiver and Release.**

Purchaser hereby releases and fully and forever discharges the City from any and all claims, demands, debts, guarantees, liabilities, obligations, liens, general, special, or consequential damages, losses, or potential losses, through any and all actions or causes of action of any nature whatsoever, whether known or unknown, foreseen or unforeseen, at law or in equity or by statute, that Purchaser now has or that may subsequently accrue to Purchaser, that is based upon, arising out of or in any way relate to the Tasers, including without limitation any and all such claims, demands, debts, guarantees, liabilities, obligations, liens, damages or losses based upon, arising out of or in any way relating to (A) this Agreement, (B) personal injuries caused by the Tasers or (C) the Tasers being dangerous, unsafe or not in working order.

**7. General Provisions.**

The laws of the State of Washington, without giving effect to principles of conflict of laws, govern all matters arising out of or relating to this Agreement. The parties shall bring any litigation arising out of or relating to this Agreement *only* before the Snohomish County Superior Court. This Agreement constitutes the entire agreement of the parties relating to the subject matter of this Agreement. This Agreement supersedes and replaces all other written or oral agreements thereto. No amendment to this Agreement will be effective unless in writing and signed by the Mayor of the City and by the authorized representatives of the other party.

Pricing effective 10/01/25 and valid for 90 days. Equipment must be properly packaged as follows and must be received by December 31, 2025. Limit L+W+H to 45 inches and weight to 30 pounds with no Styrofoam pellets or shredded packing material. Accredited Security deducts for engravings, serious cosmetic issues, unmarketable cartridges, unmarketable holsters, oversize, overweight and otherwise inferior packaging and deducts 50% (FIFTY PERCENT) for registered equipment. Said equipment is to be shipped via City's preferred method at City's sole expense to: "Accredited Security, 1711 Persimmon Dr, Naples FL 34109-0309
