FLOCK GROUP INC. AMENDMENT

This amendment (the “**Amendment**”) is made between Flock Group Inc. (“**Flock**”) and WA - Everett PD (“**Customer**”), collectively referred to as (the “**Parties**”).

1. Scope. This Amendment supersedes and amends the previously executed agreement between the Parties, dated 4/14/2025, relating to the provision of services by Flock to Customer and any schedules attached thereto or incorporated therein by reference (the “**Agreement**”). The remainder of the Agreement shall remain in full force and effect.
2. Conflict. In the event of a conflict between this Amendment and the Agreement or any previous amendment, the terms of this Amendment will prevail.
3. Capitalization. Any capitalized terms used in this Amendment will have the same meaning as in the Agreement, unless expressly defined otherwise.
4. Effective Date. This Amendment will become effective when executed by both Parties (the “**Effective Date**”).

The Agreement is amended as follows: Billing frequency shall be adjusted to align with the date of the last Dock 3 is installed and validated. The Customer shall retain the right to opt out at any time during the remaining 365-day opt-out period, which shall remain unchanged.


